**Call to Order:** 1. Meeting was called to order at 1:04 p.m. by District Governor Ken Wallander.

**Pledge** 2. Pledge of Allegiance was led by IPDG Gary Colton.

**Song & Prayer** 3. Song, God Bless America, was led by PDG Vic Voigt.  
Prayer was given by IPDG Gary Colton.

**Introductions** 4. Special guests were: Lion Bud Nitzke, Lion Carl Rassmussen and Lion Helen Mark from Oxford Lions and Lioness Pat Weber and Lion Phil Weber from Sherwood.

**Approval Of Agenda** 5. Motion by PDG Ken Rhode, second by Lion Bill Wessing to approve the agenda as as printed and submitted. Motion carried.

**Remarks by DG** DG Ken Wallander commented on the new Family Unit Membership and the progress is more with the starting of new clubs featured as family clubs and also members of significant others that are members already. So the new membership campaign is not doing as well as anticipated—but time will tell.

**Tail Twister** 6. Tail Twister Lion Irv Korth warned Lions that any conversation not recognized by DG Ken Wallander will be subject to fines.

**Roll Call** 7. Roll Call was taken when Cabinet Members introduced themselves for the visitors. There were 25 Cabinet Members present.

**Treasurer Report** 9. **Motion** by PDG Ken Rhode, second by IPDG Gary Colton to accept the Treasurer's Report as given. Motion carried. (Attachment sent)

**Old Business:** 10. Family Unit Membership, DG Ken Wallander reported it would cost the State Lions too much—about \$400/ District to offer as International is doing. A copy of the resolution was provided by PDG Clayton Sengbusch. Members of the District Council of Governors are reviewing this concern.

**Motion** by PDG Vic Voigt, second by Lion Dennis Schwartz to table any Family Unit Membership action until next Cabinet Meeting. Motion carried.

**New Business** 11. A. LEO Camp Calendar Project, as explained by LEO Chr Lion Bill Harris—So far the Leo Clubs are from Sherwood and Neshkoro that would be working on the project. See attached Sheet. **Motion** by Lion Al Sabel, second by PDG Paul Tadych to have District 27-B1 sponsor and support the LEO Camp Calendar Project. Motion carried. This project has been pre-approved by Wisconsin Lions Foundation and the Council of Governors.

B. PDG Herb Schneider reported that the size of District 27-B1 could be a factor with the problem of obtaining a candidate for Vice District Governor. PDG Herb Schneider requested that DG Ken Wallander propose a change of equity among the Districts to the Council of Governors for consideration. This was made as a **motion** by PDG Herb Schneider, second by PDG Clayton Sengbusch. Motion carried.

PDG Richard Christianson reported that the Valder's Viking Ship was requested to be entered and present at the Parade. **Motion** by PDG Vic Voigt, second by PDG

Paul Tadych that the District submit the Viking Ship for participation in the July,2007 Lions International Parade at Chicago. Motion carried.

1. Layout and concept.

  - b. Camp week per month in calendar (statement of week)
  - c. Theme page in front explaining Lions camp, Lions & Lioness programs, and focus on Leo Clubs (one of calendar's objectives is to develop inspiration in young people to become Leo member or start Leo club.
  - d. Front page with classic camp photo collage with year
  - e. Rear page with Improvement project photos and listing of all DG's in state, Foundation officers, etc.
  - f. Witte throughout on gratitude, attitude, life tools.
  - g. Commendation of 27 B1 Leos behind the project.
2. Work on calendar would be by district Leo clubs after summer camp and during September, and October. This could be accomplished in several joint sessions at camp for all 4 clubs (or more). Fun, learning, and fellowship occurs during the layout sessions. Each month would be laid out, and front, back and theme pages would be set. Cabinet or WLF to provide printed material to accompany pictures each year. Deliver to print shop by mid October. Printed calendars ready middle November. Propose print quantity of 10,000 at cost including layout of \$12,256. Leo work would reduce this as this cost includes all layout.
3. Distribution to all district clubs and campers. Propose sell to each club quantity of 100 for \$200. Tell clubs to give each member calendar and remainder to the local schools. Give to campers 2 each no charge.
4. The program could be expanded to more districts or the state as the camp serves the needs of the entire state.
5. Would be possible that the cabinet for 27B1 should include calendar coordinator in future if this project goes ahead. This is in addition to the Leo Chair.

**RESOLUTION #1**

**Purpose:** To provide the Lions of MD 27 Wisconsin the option of a family membership dues structure.

**Whereas:** Lions Clubs International, by vote of the delegates at the 2006 International Convention, now provides for a family dues structure, and

**Whereas:** A family dues structure may provide incentive for family members of Lions to join the same club, and

**Whereas:** It is desirable to provide the Lion family members to join at a reduced dues fee, and

**Whereas:** Article V, of the Multiple District By-Laws, District Finances, Page 34, Section 1, sub. (a) Per Capita Tax states as follows: The annual per capita tax to be levied upon each member of all clubs in Multiple District 27: effective July 1, 1999 shall be \$10.50.

**Therefore be it resolved:** Effective January 1, 2008, Article V, Section 1 sub b, of the Multiple District By-Laws be changed to sub c, and

**Further be it resolved:** Effective January 1, 2008, Article V, Section 1 sub b shall read as follows:

1. The first family member shall pay the annual per capita tax as stated in Article V, Section 1, sub a, above.
2. Subsequent qualifying family members, according to LCI standards, up to four (4), shall pay an annual per capita tax equal to one-half (½) half of the per capita tax paid by the first family member as described in sub-section (a) above.

This Resolution needs only a simple majority to pass.

**Resolution #2**

**Purpose:** To clarify the duties and responsibilities of the State Convention Committee.

**Whereas:** The Wisconsin Lions in Convention have approved the restructuring of the State Lions Convention and how it is managed, and

**Whereas:** The current language in By-Law Article IV, section 2 is limited to Convention Site inspections for the Committee, and

**Whereas:** The scope of the State Convention Committee is now to assist the Convention Coordinator in all aspects of the Convention.

**Now therefore:** Article IV, section 2, sub. c, d, and e, will be deleted.

Article IV, section 2, sub. a. shall read as follows:

a. "The State Council shall appoint a State Convention Committee composed of five members. Each member shall be appointed for a term of three (3) years from each of the Districts in the following manner:

2005-2006 D2	2008-2009 D1
2006-2007 C1	2009-2010 C2
2007-2008 B2	2010-2011 B1
2008-2009 A1	2011-2012 A2
2009-2010 E2	2012-2013 E1

Appointments for subsequent years shall be in the same order

In addition to the above appointments by the District Governors, the State Convention Coordinator may appoint up to three (3) additional members to serve on the Committee. These appointees shall be on an annual basis, renewable at option of the Committee Chair.

b. The Coordinator of the State Convention shall be the Chair of the Committee.

c. "The Committee shall be responsible for reviewing, checking and investigating the credentials of each prospective Convention City. The Committee shall submit its recommendation to the State Council for approval. In addition, the Committee, under the direction of the Committee Chair, shall coordinate all aspects of the convention."
